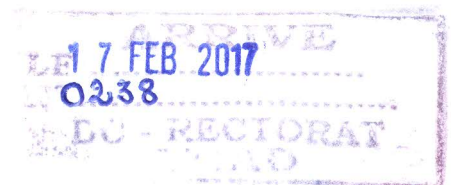

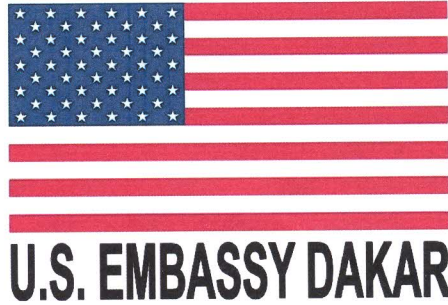
La date limite de soumission des dossiers est fixée au **vendredi 10 mars 2017**.

## FULBRIGHT FOREIGN STUDENT PROGRAM FOR 2018

### Call for applications

The U.S. Embassy is pleased to announce the call for application for the Fulbright Foreign Student program.

This scholarship is for people who would like to earn a 2-year Master's degree from a U.S. University.

Candidates may apply via the U.S. Embassy website by filling-out the Fulbright application form and sending it to: [FulbrightSenegal@state.gov](mailto:FulbrightSenegal@state.gov)

**The deadline to apply is Monday, March 10, 2017.**

#### *Eligibility criteria:*

- Candidates must be Senegalese citizens residing in Senegal;
- People who have studied in the U.S. for over a semester are not eligible;
- Candidates must have a highly qualified academic background;
- Candidates must have a Master's degree (Master 1 + 2);
- Candidates must have a strong level of English (reading, writing and speaking);
- Candidates must be serious and motivated to properly conduct their program and return to Senegal after completion;
- Candidates who have already benefited from State Department exchanges are not eligible;
- Local employees staff (LES) abroad employed by the State Department/United States Agency for International Development (USAID) are ineligible for grants during the period of their employment;

#### *Women and people with disabilities are highly encouraged to apply*

- TOEFL, GRE, GMAT tests will be offered to preselected candidates;
- The final selection will be done by the Washington D.C. Fulbright Office;
- Successful candidates will be travelling between January and August 2018;

*Please note that due to the large number of applications, only selected candidates will be contacted.*
